- B. Ski NB Committees M. Leger
  Speed Camp met with Crabbe to confirm logistics. Michele trying to secure a special guest.
  - U12-14 Poley Camp technical plan in progress. Need to finalize duration (2 or 3 days). Also trying to secure a special guest.
  - Non-FIS U18 race series in Quebec five races, first is in January. Michele to prepare summary and Carla will send to clubs for distribution.

- B. Canada Winter Games Update
  - MTO volunteer process everyone should receive an email from CWG committee with instructions to register.
  - Minor officials and general volunteers Carla to send document with instructions for volunteering to NB clubs and AAA with deadline to respond. After that date will send to all PTSOs outside Atlantic.
- C. AAA Update
  - Final change to selection criteria document for NB Cup U14+ drop one race. Maximum of six results. Carla to distribute to clubs and post on website.
  - Quota for Whistler Cup still under discussion.
- 6. New Business
  - A. Strategic Priorities & Primes C. MacNeil Sponsorship Program – large spend with World Cup Supply for CWG. Should reach out to them. Suggestion was that perhaps the first priority is retaining athletes then sponsorship will come.
  - B. Program Evaluation
    - Athlete, Official, Coach need to create a plan for each area and can then create the evaluation plan for each.
    - A lot of discussion on plan for Athlete development evolve U16 HPP, create plan for FIS and non-FIS.
    - Division 1 ski teams in NorthEast are importing athletes from West versus using ours. Need to influence that direction.
    - Train athletes to focus on achieving U14 and U16 national/international events but no focus beyond those. Time off school is also a big barrier for U16+. How do we balance athletics and academics..
    - More discussion required to document the objectives and barriers and determine how to address.
    - Dick and Ben expressed interest in priming the Athlete plan and evaluation
